



# Pursue the Future Campaign ENTERS FINAL LAP!

#### The five-year campaign

to secure \$40 million for Truman entered its final year on July 1. With commitments of more than \$35.2 million at the time of printing, the Pursue the Future campaign is in a strong position and poised to surpass goal by the end date of June 30, 2018.

In addition to a few recent major gift commitments, the past year has been significantly bolstered by strong financial support from alumni and friends around the country through regional campaign efforts. As of this June, the campaign has hosted major events in seven of our 10 regional markets. Three more regional campaign events and a number of small gatherings will continue to allow the University to maintain momentum through the final year of the campaign.

### \$25,000 Challenge Gift will help Truman Celebrate Sesquicentennial Year

The University, founded by Joseph Baldwin in 1867, will be celebrating its sesquicentennial this year. The 150 year milestone also provides an opportunity for alumni and friends to provide financial support to help support the next 150 years and beyond.

To enhance the celebration activities, Mike ('85) and Janet ('84) McClaskey of Castle Pines, Co., have designated \$25,000 from their overall cash commitment of \$100,000 to be used as a challenge gift for the sesquicentennial year.

Mike, who is currently serving as the president of the Foundation Board of Directors, knows the importance private support will play in Truman's future. He and Janet hope their challenge gift will encourage alumni and friends to join the pursuit.

The gift from the McClaskeys will be used in the **1867 Challenge** this fall to generate support for the Truman Fund for Excellence. This unrestricted fund allows the University to address significant needs as they arise. During the challenge, which will last 1,867 minutes (roughly 31 hours) Truman alumni and friends will have the opportunity to provide financial support and take advantage of the matching funds from the McClaskey's challenge gift. sport athlete, a string of injuries would keep him off of the court, as well as the baseball field, for much of his college career. However, through a generous provision in their will, Paul and his wife Alicia ('74) are ensuring that Truman's rich athletic heritage will thrive.

A poster child for the liberal arts, Paul has led an action-packed life as a successful businessman and entrepreneur. After graduating from Truman State University he went on to pursue graduate studies in finance and economics. Following a successful career with Edward Jones, in 2013

Paul and his daughter, Traci Garnett-Froscheiser, founded Garnett Investment Strategies.

Paul has also been involved in more than 20 equity companies and has demonstrated strong entrepreneurial skill with numerous start-up companies growing into successful businesses. Successes for which Truman helped prepare him. "I learned the values of capitalism in my economics classes while at Truman. It was invaluable." he says. Paul also loves assisting his community and the state of Nebraska by his involvement in economic development spanning 35 years.

### Scholarship Commitments with a Global Impact

When a student's pursuit takes them across the globe, trying new food can be one of the most exciting – and one of the most daunting – prospects. Food tells so much about a culture and is central to the travel experience. This was definitely the case for Foster Speichinger, the spring 2017 intern to Wu Hua county in rural Guangdong Province, China. Foster received the Cheung Annual EFL Scholarship which enabled him to travel abroad to teach English as a foreign Language in rural China. The experience, made possible by generous support from Chi and Candace Cheung from Jefferson City, Mo., gave Foster the opportunity to advance his Chinese language skills, meet new people, and – of course – cultivate a love of Chinese cuisine. Learning the recipe for garlic mint duck sauce might seem trivial, but on a deeper level that recipe will forever connect Foster back to his experience in Guangdong Province, the people he met and the life lessons of living abroad. None of this would have been possible without the vision of the donors who funded his journey thousands of miles from home.



In addition to funding the EFL Scholarship, Chi and Candace also support the New Horizons Community Support Foundation Scholarship that provides tuition, room and board for students from the Guangdong Province to study at Truman. Four students have received the scholarship, which began in 2015. One of the recipients, Jianxiu Cai, is a transfer student navigating a lot of the same academic challenges as other students. On a more practical level, she realized she needed to learn how to make a sandwich. Back-to-back classes necessitate a quick and portable meal to tide her over. What to eat in a time crunch is small in the scheme of all Jianxiu is learning at Truman, but it's also a piece of America she wouldn't have experienced without having traveled the globe to study at Truman. Thanks to generous scholarship support, the New Horizons recipients are free to immerse themselves in their studies and the culture. The next three years at Truman will be educational, both in and out of the classroom for the other New Horizon Scholarship students.

The Cheung's five-year commitment to both scholarship funds will afford many students access to rich crosscultural experience. Through their generosity, students have the opportunity to gain global perspective and realworld experience — with a side of culinary adventure. From PB&J to garlic mint duck sauce, scholarship support has opened exciting doors to students who otherwise wouldn't have been able to afford these life-changing cultural experiences.

# \$90,000 Commitment Creates Excellence Fund for the School of Business
